The undersigned is informed and believes that:

COUNT 1

On or about April 9, 2015, in the above named judicial district, the crime of EVADING AN OFFICER, WILLFUL DISREGARD, in violation of VEHICLE CODE SECTION 2800.2(a), a felony, was committed by Francis Jared Pusok, who did willfully and unlawfully, while operating a motor vehicle and with the intent to evade, flee and otherwise attempt to elude a pursuing peace officer's motor vehicle while all of the following conditions existed: the peace officer's motor vehicle exhibited at least one lighted red lamp visible from the front and the defendant(s) saw and reasonably should have seen the lamp, the peace officer's motor vehicle was sounding its siren as was reasonably necessary, the peace officer's motor vehicle was distinctively marked, the peace officer's motor vehicle was operated by a peace officer. It is further alleged that the defendant(s) drove with a willful or wanton disregard for the safety of persons and property.

COUNT 2

On or about April 9, 2015, in the above named judicial district, the crime of RESIST, OBSTRUCT, DELAY OF PEACE OFFICER OR EMT, in violation of PENAL CODE SECTION 148(a)(1), a misdemeanor, was committed by Francis Jared Pusok, who did willfully and unlawfully resist, delay and obstruct K Kraft who was then and there a peace officer attempting to and discharging the duty of his/her office and employment.

COUNT 3

On or about April 9, 2015, in the above named judicial district, the crime of VANDALISM OVER \$400 DAMAGE-DAMAGE/DESTROY, in violation of PENAL CODE SECTION 594(a), a felony, was committed by Francis Jared Pusok, who did unlawfully and maliciously damage and destroy real and personal property, to wit, CHAIN LINK FENCE AND FENCE POSTS not his/her own, belonging to Alexander R Azat , the amount of said damage being over \$400.00.

COUNT 4

On or about April 9, 2015, in the above named judicial district, the crime of GRAND THEFT OF LIVESTOCK BY LARCENY, in violation of PENAL CODE SECTION 487a(a), a felony, was committed by Francis Jared Pusok, who did feloniously steal a horse, which was the personal property of Dan Pollock .

COUNT 5

On or about April 9, 2015, in the above named judicial district, the crime of CRUELTY TO AN ANIMAL, in violation of PENAL CODE SECTION 597(b), a felony, was committed by Francis Jared Pusok, who did unlawfully OVERRIDE, OVERLOAD, OVERWORK, DEPRIVE OF NECESSARY DRINK OR CAUSES THE HORSE TO BE OVERRIDDEN, OVERLOADED, OVERWORKED AND DEPRIVED OF NECESSARY DRINK.

COUNT 6

On or about April 9, 2015, in the above named judicial district, the crime of UNDER INFLUENCE OF A CONTROLLED SUBSTANCE, in violation of HEALTH AND SAFETY CODE SECTION 11550(a), a misdemeanor, was committed by Francis Jared Pusok, who did unlawfully use and be under the influence of a controlled substance, to wit, Amphetamine and Marijuana.

"NOTICE: Conviction of this offense will require you to register pursuant to Health and Safety Code section 11590. Failure to do so is a crime pursuant to Health and Safety Code section 11594."

COUNT 7

On or about April 9, 2015, in the above named judicial district, the crime of POSSESSION OF AMMUNITION, in violation of PENAL CODE SECTION 30305(a)(1), a felony, was committed by Francis Jared Pusok, who did unlawfully own, possess and have under control ammunition and reloaded ammunition.

It is further alleged that the defendant is prohibited from owning or possessing a firearm pursuant to Chapter 2 and 3 of Division 9 and sections 8100 and 8103 of the Welfare and Institutions Code, having been previously convicted of the following offense(s):

COUNT 8

On or about January 5, 2015, in the above named judicial district, the crime of RECKLESS DRIVING IN AN OFFSTREET PARKING FACILITY, in violation of VEHICLE CODE SECTION 23103(b), a misdemeanor, was committed by Francis Jared Pusok, who drove a vehicle in an offstreet parking facility in willful and/or wanton disregard for the safety of persons or property.

COUNT 9

On or about January 5, 2015, in the above named judicial district, the crime of DRIVING OR TAKING A VEHICLE WITHOUT CONSENT, in violation of VEHICLE CODE SECTION 10851(a), a felony, was committed by Francis Jared Pusok, who did drive a vehicle, a 2008 YAMAHA RG MOTORCYCLE LICENSE 732547X CA, without the consent of the owner, Jose A Carlos Limas , and with the intent to deprive the owner of title and/or possession of the vehicle.

COUNT 10

On or about April 6, 2015, in the above named judicial district, the crime of DRIVING OR TAKING A VEHICLE WITHOUT CONSENT, in violation of VEHICLE CODE SECTION 10851(a), a felony, was committed by Francis Jared Pusok, who did take a vehicle, a 2003 SUZUKI MOTORCYCLE LIC. 16S4239 CA, without the consent of the owner, Sean Stegmann , and with the intent to deprive the owner of title and/or possession of the vehicle.

COUNT 11

On or about February 19, 2015, in the above named judicial district, the crime of DRIVING OR TAKING A VEHICLE WITHOUT CONSENT, in violation of VEHICLE CODE SECTION 10851(a), a felony, was committed by Francis Jared Pusok, who did take a vehicle, a 2007 HONDA MOTORCYCLE CRF250, without the consent of the owner, Travis Lamont St Clair and Brandon Twaddell , and with the intent to deprive the owner of title and/or possession of the vehicle.

COUNT 12

On or about April 9, 2015, in the above named judicial district, the crime of RECEIVING STOLEN PROPERTY WITH A VALUE EXCEEDING \$950, in violation of PENAL CODE SECTION 496(a), a felony, was committed by Francis Jared Pusok and Jolene Rhonda Ruth Bindner, who did conceal, sell, withhold, or aid in concealing, selling or withholding property, exceeding nine hundred fifty dollars (\$950) in value, from the owner, specifically, U-HAUL TRAILER, knowing the property to be so stolen or obtained.

COUNT 13

On or about April 9, 2015, in the above named judicial district, the crime of RECEIVING STOLEN PROPERTY WITH A VALUE EXCEEDING \$950, in violation of PENAL CODE SECTION 496(a), a felony, was committed by Francis Jared Pusok and Jolene Rhonda Ruth Bindner, who did conceal, sell, withhold, or aid in concealing, selling or withholding property, exceeding nine hundred fifty dollars (\$950) in value, from the owner, specifically, TRAILER, knowing the property to be so stolen or obtained.

COUNT 14

On or about April 9, 2015, in the above named judicial district, the crime of RECEIVING STOLEN PROPERTY WITH A VALUE EXCEEDING \$950, in violation of PENAL CODE SECTION 496(a), a felony, was committed by Francis Jared Pusok and Jolene Rhonda Ruth Bindner, who did conceal, sell, withhold, or aid in concealing, selling or withholding property, exceeding nine hundred fifty dollars (\$950) in value, from the owner, specifically, TRAILER, knowing the property to be so stolen or obtained.

It is further alleged pursuant to Penal Code sections 1170.12(a) through (d) and 667(b) through (i) as to count(s) 1, 3, 4, 5, 7, 9, 10, 11, 12, 13, 14 that said defendant(s) Francis Jared Pusok, has suffered the following prior conviction of a serious or violent felony or juvenile adjudication:
